WALLEYES FOR TOMORROW

On Saturday, January 12, 2013, Joe France from the Polish Palace hosted a speaker from Walleyes for Tomorrow. Those of you that have given me your email addresses were notified of this meeting.

Mike Arrowood and Dave Gordon spoke on behalf of the organization. The hope was too get enough interest to possibly start a Price County Association of Walleyes for Tomorrow.

There are 15 chapters in Wisconsin at the present time. They work with the DNR and are a project -oriented group. They are a corporation and are tax exempt as a non-profit organization.

Chapters submit projects to be reviewed by the WFT board. (They have rebuilt culverts that were too small. They have built bridges on streams that were needed for better spawning. They have built 154 rock habitats in Lake Winnebago. They own and operate seven fish hatcheries. They have published a book on how to run a fish hatchery.)The DNR have adopted their method of determining a fish's age.

Each chapter would agree to have a fundraiser at least once yearly and 10% of what is raised would stay with the local chapter to carry out the needs of the chapter.

They help chapters determine what projects would help their lake increase walleye. They **WILL NOT** introduce new species to any lake. They use sound science in their decisions.

It was decided by people in attendance, to proceed with another meeting to see how/if we get started. 2nd meeting. Feb.15, 8p.m.

President's Comments As spring approaches, the Solberg Lake Association is preparing for a few projects for the summer. Last year we placed some Christmas tree cribs in the lake for perch habitat and we will do this again this year.Last fall we planted perch in the lake. I have asked the DNR again to consider allowing us to plant walleye or musky with no success. I did get the fish management DNR person for our area to commit to attending our spring meeting. I have also applied for a permit to destroy goose eggs for If you would like to goosecontrol. participate in this please contact me. The aquatic plant management plan has been finished and sent to the DNR. I hope to hear from them soon. Our association has tried for the last two vears to have a clean boat/clean water program active at our boat landing. We need to have more people help in this effort.
